Investigation: Sex Abuse/Abduction V/O 10 Pct  
 Subject: Locate C/V-Interview, photos, canvas.

1. The u/s was present at the Holy Apostle Church Soup Kitchen 28 st & 9 ave NYC. I spoke with the Assistant Admin Mgr Mrs Linda Adams #212-807-6799 who stated the c/v H. was near b/ staying at a friend's apartment since the incident. Mrs Adams contacted the c/v who agreed to allow us to her friend's apartment for her interview.

2. The c/v stated on 9/15/04 at about 0555 hrs after taking the train to work she was walking down 28 street towards her job. I saw a male white about 18-20 leaning on a fence talking on a cell phone. I passed the male and he grabbed my behind. I stopped and asked him what happened? I said "Excuse Me" he was saying something, I dont know what. I asked again "What did you do?" He wanted to show me something on his cell phone, I dont know what. He grabbed my neck pulling me closer to him. He said "Get In his car" and was pushing me in the front passenger door. I screamed "Help-Help" there was no one there. He tried to cover my mouth and punched me in the face a lot. He opened the car back door and tried to get me in there. He picked up my bag. I think I blacked out a little, I was dizzy it took me a while to get my stuff together. I had his cell phone and went to my job. The police came later with the ambulance. End of Statement.

3. The c/v was taken on a canvas of the area to get the exact area of the incident. There were possible video cameras located for possible viewing. The c/v was taken to the 010 Pct PDU for Photo Manager viewing. The c/v viewed M/W-H 18-25, Blue eyes in the Manhattan, Bronx, Brooklyn, Queens and Staten Island Pcts. 1-Possible photo was located NYSID # Arrest#: M04636181 Dean Crawford M/W/19.
